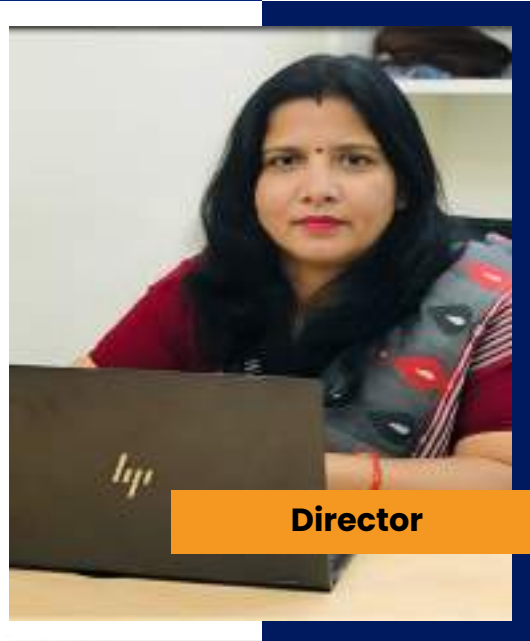
Growth Path and Plan
